Rest of the rules and regulations of the University for grating study leave will remain unchanged.

In compliance to the decision taken on Item No. 2 by the Academic Council in its 250th meeting held on 13.01.2017, the rules for selection for Doctorate Degree Programme to in-service candidates is as follows :-

1. Study leave shall be granted by the Competent Authority (Vice Chancellor, JNKVV) on the recommendation of the concerned Head of the Department and Study Leave Granting Committee (SLGC) constituted by the University.
2. In-service Teachers / Scientist shall be allowed to pursue Ph.D. only from Central/State/Deemed Agricultural Universities/ IITs in the relevant subject through course work.
3. The candidate may be permitted for Ph.D. degree programme from traditional University, if the degree programme in that specific subject is not available in any of the agricultural universities at national level.
4. Minimum one seat will be reserved in each department of the University for in-service candidate.
5. Study leave shall be granted to Assistant Professor/ Scientist/ SMS after a minimum of 03 years of continuous service and clearance of probation period based on seniority.
6. The case of granting study leave to a candidate, who has been awarded fellowship/ scholarship from ICAR/ UGC/ CSIR/ MHRD/ IITs etc. will be considered on priority over seniority.
7. In the event the candidate from the University is admitted for Master/ Doctorate degree programme, then he/ she will be permitted as follows :-
 - (i) Study leave for one year/ two semesters whichever is earlier to complete the course work.
 - (ii) Study leave is extendable by six months or one semester whichever is earlier if there is adequate reason.
 - (iii) In any case study leave of more than one and half year/ three semester whichever is earlier will not be granted.
 - (iv) After completion of one year or extendable period, the candidate has to join the duty at the original place of posting from where his/ her salary is drawn with intimation to the Registrar and Dean Faculty of Agriculture/ Director Research Services/ Director Extension Services through proper channel.
 - (v) In the event of repeat in any subject, the candidate has to appear in the examination(s) on leave and at his own cost.
 - (vi) Candidate pursuing Ph.D. from JNKVV, Jabalpur will conduct the experiment under the supervision of the chairman of advisory committee after joining the duty.
 - (vii) In the event the candidate is pursuing the degree from other University an MoU has to be signed state that on completion of the course work and other examination (comprehensive etc.) from the University in which the candidate is registered, research work will be conducted at JNKVV, Jabalpur under co-advisor and submission of thesis in the University where the candidate is registered for the award of degree.
 - (viii) The in-service candidates born in Krishi Vigyan Kendra will be considered Leave Without Pay on any objection raised from Indian Council of Agricultural Research, New Delhi and all actions will be applicable as per notice of ICAR.

8. Study leave for Ph. D. Degree shall be granted by competent authority on full time one year or two semester whichever is earlier extendable by six months or one semester whichever is earlier to the candidate pursuing Ph.D. from the University or outside of the University.

Note :- The above terms and conditions will supersede the related terms and conditions in vogue for grant of study leave and permission for registration for higher studies to in-service candidate of the University.
